



## Introduction to Realist Evaluation for Social Services (10 November 2022)

### Course Description:

The course is designed to provide social service and community-based professionals, as well as policy-makers, with an introduction to theories and concepts of realist evaluation.

In community development and other fields of practice, interventions are often described as being complex and have outcomes that are dependent on context and are challenging to evaluate. Realist evaluation can help make sense of the outcomes from these types of interventions. Instead of providing one-off verdicts on its success or failure by asking, “Does the intervention work?”, realist evaluation examines “What works, for whom, under what circumstances and why?”. Recognising that interventions do not work in the same way for everyone, everywhere, realist evaluation seeks to systematically develop and test theory, specifically the causal mechanisms that are activated in different contexts, leading to different outcomes. It is multi-method and draws on both quantitative and qualitative methods.

### Course Objectives:

- Understand what realist evaluation is, when to adopt it and how it differs from other evaluation approaches
- Be able to describe the stages of a realist evaluation
- Understand the role of programme theory in realist evaluation and be able to develop and refine one

### Course Schedule:

The workshop will be conducted **in-person** at the NUS Kent Ridge Campus (The Shaw Foundation Building, Block AS7). Participants will be informed of the venue after their registration is confirmed.

### Pre-requisites:

At least a university degree in any discipline, with preference given to social science and community health disciplines and at least 2 years of working experience in the social service sector.

### Who Should Attend:

Social workers, policy-makers, counsellors, community psychologists, community and allied health professionals. All other professionals and practitioners in the social service and community health sectors, particularly those working in multi-disciplinary teams.

## Trainer:

*Dr Robyn Tan* is a Research Fellow at the Institute of Policy Studies, NUS. Her research interests include studying the implementation of policies, programmes and interventions. She has a keen interest in applying theory-driven evaluation approaches, particularly, the realist logic of inquiry in real world policy and service settings.

## Course Fees:
