About the Course

This course aims to provide an exchange and learning platform for social workers to discuss the management of persons with dementia and the care issues that their caregivers face. Through case discussion and experiential learning, participants will learn to integrate knowledge on dementia, the philosophy and principles of care, coping with the trajectory of illness till end of life, and translate knowledge and skills into practice.

At the end of the course, participants will be able to:

- 1. Equip and strengthen social workers' knowledge on dementia trajectory and care transition.
- 2. Develop a deeper understanding on impact of dementia towards caregivers.
- 3.Be able to work through the grief and loss experienced by persons with dementia and their caregivers.
- 4. Enable participants to apply person centered care principles in working with persons with dementia and their caregivers.
- 5.Acquire knowledge and the use of Advanced Care Planning (ACP) and Lasting Power of Attorney (LPA) in working with persons with dementia and their caregivers.

Who Should Attend

This course is targeted at Social Workers and all helping professionals who work with persons with dementia.

DR GOH SOON NOI Head, Medical Social Services Department, Changi General Hospital


