## **Programme Structure for students admitted before AY2019/20**

## **Objectives**

The objective of the MSW programme is to produce the leaders of social work profession in direct practice, social policy and research, and social administration and development. Integrative learning, interdisciplinary exposure and innovative capacity building are the key pedagogical features of our MSW programme.

The MSW programme is designed to facilitate students' systematic integration of social work professional values and practice, theory and practice, and research and practice in every class. It also offers students interdisciplinary learning opportunities to take courses from other departments within the faculty as well as public policy, public health, and health sciences in other faculties and schools to their special interest. In our MSW programme, students can expect to build their innovative capacity of being future-ready social work professionals who are equipped with strong and distinct leadership quality and cross-sector mobility in the Singaporean social service sector.

With effect from AY2019/2020, students admitted into a government-subsidised graduate coursework programme who take longer than the normal candidature period to complete their degree requirements are required to pay full unsubsidised fees, during the extended semesters.

## **Programme Structure**

There are three options for the Master of Social Work:

- 1. Master with Specialisation (Family/Community or Health);
- 2. General Master without Specialisation; and
- 3. Self designed Master without Specialisation.

A candidate for the degree of Master of Social Work must offer not fewer than ten courses. The ten courses include:

## 1. For Master with Specialisation (Family/Community or Health)

- 4 essential courses; and
- 5 elective\* courses (including 1 specialization related supervised project or practicum if on the specialization track); and,
- 1 general elective course (including any relevant graduate course across Faculties/Schools such as the Lee Kuan Yew School of Public Policy, NUS Business School, and the Department of Epidemiology and Public Health, Faculty of Medicine, NUS)

## 2. For General Master without Specialisation

- 4 essential courses; and
- 5 elective\* courses from either of the specialization tracks and 1 general elective (including any relevant graduate course across Faculties/Schools)

## 3. For Self designed Master without Specialisation

- 4 essential courses; and
- 6 electives\* in a self-designed curriculum including relevant cross faculty graduate courses as approved by the department.

Candidates on a specialization track are required to complete a Supervised Project (SW5112) or Fieldwork Practicum (SW5111 or SW5111A or SW5111B). The Supervised Project will be an independent and original piece or work which involves innovative and original initiatives such as developing a new social service programme/policy or conducting an original piece of field research. SW5111 and SW5111B requires 400 fieldwork hours and field supervision under an approved supervisor; SW5111A requires 800 fieldwork hours and field supervision under an approved supervisor. Field integration seminars are scheduled in conjunction with SW5111A.

\* Students from the AY2014/15 intake onwards without a BSW are required to take the Practicum as an elective course to fulfil graduation requirements regardless of whether or not they are doing a specialization track.

In addition, the Dean of the Faculty of Arts and Social Sciences, on the advice of the Head of the Department of Social Work, may require a candidate to undertake such other work as may be deemed relevant to his/her candidature for the degree of the Master of Social Work.

- Cross faculty courses such as from the Lee Kuan Yew School of Public Policy, NUS Business School, or the Department of Epidemiology and Public Health, Faculty of Medicine.

Five elective (level 5000 or level 6000) courses from either of the specialization tracks offered by the Department of Social Work and 1 elective for General Master) OR six electives in a self-designed curriculum including cross-faculty graduate courses as approved by the Department for Self-Designed Master.

- 2. Unless otherwise indicated, each course shall be of one semester's duration.
- 3. The programme structure and the courses offered may be modified from time to time.

# **Continuation Requirements**

• Grade Point Average (GPA) should not fall below 2.50 for two consecutive semesters or 3.00 for three consecutive semesters. Termination of candidature will result if a student fails to maintain the minimum GPA as stipulated above. A student will be issued a warning for any semester in which his/her GPA falls

- below that required for graduation (3.00 for a Masters degree). If, in the following semester, the student's GPA again falls below the graduation requirement, but not sufficiently to warrant immediate termination, he/she will be placed on probation.
- With effect from AY2015/2016, where a course is required for the graduate candidature and the minimum grade is not met, a student may repeat:
- (a) The same course (core or elective) only once. The improved grade point of the repeat/replaced course will replace the weaker one in the Grade Point Average (GPA) computation in the semester in which the successful attempt is made; and
- (b) One-third of the curricular requirements not exceeding three courses, whichever is lower.
